The names in **red** must complete those and other requirements to remain/become active in 2012. The contact information has been provided by these individuals to UMH.

UMH judges must attend a UMH Judges' Clinic every 3 years, complete a UMH Judges' test every year, and pay annual UMH membership and licensure fees to remain active. New applicants must fulfill these and other requirements to become a UMH judge.

The UMH Judges Clinic is held in March each year and is open to judge applicants and to any interested members. It is a 2 day clinic with sessions focusing on the review of UMH rules, UMH judge's responsibilities, and demonstrations of the Mountain Horse traits and gaits.
